**Biography:** Jeffrey Fagan is Isidor and Seville Sulzbacher Professor of Law and Professor of Epidemiology at Columbia University and serves as the Director of the Center for Crime, Community and Law at Columbia Law School. He also is a Senior Scholar at Yale Law School. His research and scholarship examines policing, the legitimacy of the criminal law, capital punishment, legal socialization of adolescents, neighborhoods and crime, and juvenile crime and punishment.



**Director receives prestigious Herbert Bloch Award** 



Charis Kubrin joined UCI as an Associate Professor this fall after 11 years of teaching at George Washington University. She received her Ph.D. in Sociology from the University of Washington. Professor Kubrin's research focuses on neighborhoods, race, and violence as central to social disorganization theory.

Professor Kubrin's research also examines the intersection of music, culture and social identity, particularly as it applies to hip-hop and minority youth in disadvantaged communities. For a recent study, Charis Kubrin, coded every line of more than 400 rap songs for themes of violence, retaliation, misogyny, respect, material wealth and nihilism. Her 2005 analysis "Gangstas, Thugs & Hustlas: Identity & the Code of the Street in Rap Music" was among the University of California's 25 most frequently downloaded articles in 2010, according to UC Press.


Professor John Hipp and graduate student, Daniel Yates publish article in Criminology

Pontell has garnered the Herbert Bloch Award for outstanding service contributions to the American Society of Criminology and to the professional interests of criminology. The prestigious award-inaugurated in 1961 but not bestowed every year-was presented November 16, 2011 in Washington DC.

Dr. Pontell, the 34th recipient, joins some of the most prominent criminologists in North America. "I'm overwhelmed and deeply honored by this award," said the Professor of



Pontell has served as Vice President of ASC, a member of the Executive Board, Editor of The Criminologist, and as a member of numerous committees and editorial boards of journals in the field. He's testified on matters of crime and punishment before national commissions and the United States Congress, presented to the National Academies, been a keynote speaker at major international conferences, and has been recognized with scholarship and service awards from the American Sociological Association, the Western Society of Criminology, and the Association of Certified Fraud Examiners.



## More than 6 million students taking online courses!

Based on responses from over 2,500 academic leaders, a 2011 survey of online learning revealed that the number of students taking at least one online course has now surpassed 6 million.

"The rate of growth in online enrollements is ten times that of the rate in all higher education, " said study Co-Author I Elaine Allen, Co-Director of the Babson Survey Research Group and Professor of Statistics & Entrepreneurship at Babson College.



Key report findings include:

- Over 6.1 million students were taking at least one online course during the fall 2010 term, an increase of 560,000 students over the previous year.
- The 10% growth rate for online enrollments far exceeds the 2% growth in the overall higher education student population.
- Thirty-one percent of higher education students now take at least one course online.
- Reported year-to-year enrollment changes for fully online programs by discipline show most are growing.
- Academic leaders believe that the level of student satisfaction is equivalent for online and face-to-face courses.
- 65% of higher education institutions now say that online learning is a critical part of their long-term strategy.
